### CLE MOCK PRE-TRIAL HEARING

#### Introduction


BABSEACLE, along with its partners, organized several virtual National CLE Mock Pre-Trial Hearing Workshops in a number of countries throughout the Asia region, including Singapore, Nepal, Bangladesh, Indonesia, Myanmar, Laos, Vietnam, during the months of October-November, 2020. These national workshops were organized to support and strengthen the Annual Asia Regional Clinical Legal Education (CLE) Mock Pre-Trial Hearing, held each year at the end of November or early December.

The training materials used in the National and Regional Workshops were initially codeveloped by DLA Piper/New Perimeter and HSF and recently partially revised to be used for online training.

The mock pre-trial national workshops gave 250 law students an opportunity for practical experience in legal, analytical, and advocacy skills in a simulated courtroom and included a clear focus on access to justice, legal transparency, Rule of Law, and fair trial principles.

28 lawyers from DLA Piper/New Perimeter, HSF, White & Case, BABSEACLE, Lanna Lawyers, Kathmandu School of Law, Nepal Bar Association, Victorian Bar, The Shopfront Youth Legal Centre, Law Society Pro Bono Services, Legal Circle, Nexalegal Asia, UNDP, ACSV Legal, The Asia Foundation, , and Asia Justice and Rights assisted as trainers during the workshops.





### REGIONAL CLE MOCK PRE-TRIAL WORKSHOP

Following the seven national workshops, approximately 15-20 students from each national workshop were selected to participate in a two-day virtual regional workshop on November 21st-22nd. This regional workshop focused on sharpening the previous national workshop's legal skills. Besides, developing participants' critical thinking on legal's ethics issues in the regional context. Selected students from this regional workshop then participated in the regional event, held virtually during the last weekend of November, and the final event was taking place on December 5<sup>th</sup>.


